CORPORATION OF THE TOWNSHIP OF SEYMOUR

BY-LAW NUMBER 1984-12

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS GORE CONCESSION 15, OPPOSITE LOT 6, TRENT RIVER UNITED CHURCH, AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE AND INTEREST.

WHEREAS section 29 of The Ontario Heritage Act, 1974, authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and

WHEREAS the Council of the Corporation of the Township of Seymour has caused to be served on the owners of the lands and premises known as Trent River United Church at Gore Concession 15, opposite Lot 6, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks;

WHEREAS the reasons for designation are set out in Schedule A hereto.


THEREFORE the Council of the Corporation of the Township of Seymour enacts as follows:

- 1) There is designated as being of architectural and historical value and interest the real property known as Trent River United Church at Gore Concession 15, opposite Lot 6, more particularly described in Schedule A hereto.
- 2) The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule A hereto in the proper land registry office.
- 3) The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

SCHEDULE A
TRENT RIVER UNITED CHURCH

The reasons for designation are as follows:

The church was constructed in 1878 as evidenced by the date stone "M.E. Church 1878".

The exterior of the church is constructed of polychrome brick laid up in attractive inset panels with Gothic windows. Exterior walls and the tower are reinforced with buttresses, inset with limestone drip caps. The base of the brick bell tower creates the entrance vestibule to the sanctuary.

The interior was plastered, the ceiling was decorated with a circular medallion being itself decorated with a leaf design. An elaborate plaster moulding creates a central panel on this ceiling.

The structure is a fine example of a rural church of the time of Confederation.
