By-Law 2018-164

A By-Law to Repeal and Replace By-Law 1992-76 Being a By-Law to designate 29 Regent Street, Lindsay, in the City of Kawartha Lakes as being of Cultural Heritage Value and Interest

Recitals

1. Section 29 of the Ontario Heritage Act, R.S.O. 1990, provides that the Council of a municipality may pass a by-law designating a property within the boundaries of the municipality to be of cultural heritage value or interest.
2. Notice of Intention to Designate 29 Regent Street, Lindsay, City of Kawartha Lakes, described further in Schedule "A", has been given in accordance with Section 29 of the Ontario Heritage Act.
3. No objection to the proposed designation has been served on the Clerk of the City.
4. Reasons for Designation are set forth in Schedule "A".

Accordingly, the Council of The Corporation of the City of Kawartha Lakes enacts this By-law 2018-164.

Section 1.00: Definitions and Interpretation

1.01 Definitions: In this by-law,

"City", "City of Kawartha Lakes" or "Kawartha Lakes" means The Corporation of the City of Kawartha Lakes and includes its entire geographic area;

"City Clerk" means the person appointed by Council to carry out the duties of the clerk described in section 228 of the Municipal Act, 2001;

"Council" or "City Council" means the municipal council for the City;

"Director of Development Services" means the person who holds that position and his or her delegate(s) or, in the event of organizational changes, another person designated by Council.

"Property" means property as set out in Section 2.01.

1.02 Interpretation Rules:

- (a) The Schedules attached to this by-law form part of the by-law, and are enforceable as such.

- (b) The words "include" and "including" are not to be read as limiting the meaning of a word or term to the phrases or descriptions that follow.
- 1.03 **Statutes:** References to laws in this by-law are meant to refer to the statutes, as amended from time to time, that are applicable within the Province of Ontario.
- 1.04 **Severability:** If a court or tribunal of competent jurisdiction declares any portion of this by-law to be illegal or unenforceable, that portion of this by-law shall be considered to be severed from the balance of the by-law, which shall continue to operate in full force and effect.

Section 2.00: Designation

- 2.01 29 Regent Street, Lindsay, City of Kawartha Lakes, is designated as being of historic interest and value, described further in Schedule "A". This designation shall not preclude any changes that may be deemed necessary for the efficient use of the building but that any and all such changes shall be in keeping with the original and present character of the building and in consultation with the municipal heritage committee.
- 2.02 The City is hereby authorized to cause a copy of this by-law to be registered against the property described above in the proper Land Registry Office.
- 2.03 The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Trust, and to cause notice of the passing of this by-law to be published in the newspaper.

Section 3.00: Enforcement, Offence and Penalties

- 3.01 **Enforcement:** This by-law may be enforced by every municipal law enforcement officer and police officer.
- 3.02 **Offence and Penalty:** It is an offence for a person to contravene any provision of this by-law, and every person who contravenes this by-law is guilty of an offence and, on conviction, is liable to a fine in accordance with the provisions of the *Provincial Offences Act* and to any other applicable penalty.

Section 4.00: Administration and Effective Date

- 4.01 **Administration of the By-law:** The Director of Economic Development is responsible for the administration of this by-law.
- 4.02 **Effective Date:** This By-law shall come into force on the date it is finally passed

Section 5.00 Repeals

5.01 Repeal: By-law 1992-76 is repealed.

By-law read a first, second and third time, and finally passed, this 25 day of September, 2018.

Schedule 'A' to By-law 2018-164

Being a By-law to designate 29 Regent Street, Lindsay, City of Kawartha Lakes, as being of cultural heritage value and interest.

Description of Property

Located on the south side of Regent Street, this yellow brick home is located between William Street North and Victoria Avenue North.

Legal Description:

PLAN 1 BLK B PT LOT 15

REASON FOR DESIGNATION

Architectural Design or Physical Value:

This dwelling is a two storey Queen Anne Revival house built in 1875 of yellow brick veneer construction with a rubble stone foundation. It features a low hip roof and decorative corbelled brick ornamentation over the windows. A solid wood door is original to the home and is featured with a transom and two sidelights. Some unoriginal but sympathetic features have been added to the home including the use of six over six double hung windows, a verandah that runs across the front of the home facing north, and stained glassed windows on either side of the door.

ATTRIBUTES TO BE CONSERVED:

- Yellow brick veneer
- Rubble stone foundation
- Low hipped roof
- Decorative corbelled brick ornamentation over the windows
- Solid wood paneled door with sidelights and transom
- Verandah extending the width of the home that is either original or in the original style of the home, with chamfered Gothic style columns and decorative brackets and bargeboard designs
