Dear Renay:

Thank you for your email dated November 1, 2019 regarding heritage registers with the Trust.

You requested designating bylaws for the following properties:

- Canadian Pacific Railway Station, McClellan Ave
- City Hall, 1 Main Street South
- Mather-Walls House, 1116 Ottawa Street
- Museum Annex, 224 Main Street South

I have completed my extensive search for your request. While I was able to locate bylaws (enclosed) for City Hall, 1 Main Street South and the Museum Annex, 224 Main Street South, I am unable to locate any other bylaws.

The Mather Walls House was part of the former Town of Keewatin and while I went through as many years of the bylaws I could try to locate this bylaw, I was unsuccessful. The Mather-Walls was a provincial designation from what I can ascertain.

The CPR station was a federal designation done through the Heritage Railway Stations Protection Act. These designations were done on the recommendation of the Historic Sites and Monuments Board of Canada. I have attached a document outlining its heritage significance and the recognition authority as well as other pertinent details.

I trust this meets the needs of your request and I will now consider this matter closed.

## By-Law Number 141 - 2018

**A By-law to amend By-Law Number 104-2000 being a By-law to Designate Property under Section 29 of the Ontario Heritage Act, Lake of the Woods Museum Annex, being part of Lots 13 and 14, Block 1, Plan 3 in the City of Kenora**

Whereas Section 33.1 of the Ontario Heritage Act states that no owner of property designated under section 29 shall alter the property or permit the alteration of the property if the alteration is likely to affect the property's heritage attributes, as set out in the description of the property's heritage attributes that was required to be served and registered under subsection 29 (6) or (14), as the case may be, unless the owner applies to the council of the municipality in which the property is situate and receives consent in writing to the alteration; and

Whereas as the owner of the property at Lots 13 and 14, Block 1, Plan 3 in the City of Kenora Council of the City of Kenora has authorized for such an amendment and consented to the application under the recommendation of Heritage Kenora;

Now Therefore be it Resolved That the Council of the City of Kenora hereby enacts as follows:

1. That By-law No. 104-2000 being a by-law to designate property under the Ontario Heritage Act, is hereby amended, specifically to address the description of the brickwork and windows in the listing of the heritage attributes found in Schedule B, as follows:  
"The oak doors, oak counters, oak window trim, oak wainscotting, casement and baseboards are essential to maintain the visual integrity of the design of this period."

That Council hereby approves an amendment to bylaw number 104-2000, being a bylaw to designate the Lake of the Woods Museum Annex located at 224 Main Street South, as a heritage building under section 33.1 of the Ontario Heritage Act to replace the above paragraph with the following:

"The oak doors, oak counters (delete), oak window trim, oak wainscotting, casement and baseboards are essential to maintain the visual integrity of the design of this period. The oak counter, while removed from its original location, is extant, and will be re-purposed within the building, if possible."

2. That this by-law shall take effect and come into force upon third and final reading of the bylaw.
