At the August 18, 2008 Council Meeting, Chatham-Kent Council approved the Heritage Chatham-Kent Committee's recommendation for the Intent to Designate the Buxton National Historical Site and Museum Property located at 21975 A.D. In the Matter of the Ontario Heritage Act Notice of Intent to Designate

The Ontario Heritage Act, R.S.O., 1990, Chapter 0.18 as amended, provides that the Municipal Council may pass a by-law designating property within the boundaries of the municipality to be of cultural heritage value and interest.

The Council of the Municipality of Chatham-Kent hereby gives Notice of Intent to designate the following property:

### **Description of Property:**

The Buxton National Historical Site and Museum Property, located at 21975 A.D. Shadd Road, Part Lot 10, Concession 8, Community of Raleigh on 7.98 acres, and consisting of a restored 1861 timber frame house, wood side school house, a restore log house a.c. 12967 museum interpretation building, numerous federal & provincial plaques, a reproduction freedom bell, a park area wit baseball diamonds, playground equipment and a covered open sided pavilion, has a been identified as a property of cultural heritage value and interest.

### Statement of Cultural Heritage Value or Interest:

Nine thousand (9,000) acres were acquired in 1849 by Rev. King for the purpose of creating a settlement for refugees from slavery, which became known as the Elgin Settlement and was recognized as an area of national significance by Parks Canada in the year 2000. The Buxton School House SS #13, Raleigh, was built in 1861 and is the only known remaining school house in Canada with direct associations to slavery and the underground railroad. Most importantly is the site is renowned for its Annual Labour Day Homecoming weekend, established in 1926.

Any person may, within 30 days of the date of this Notice, serve on the Clerk, a Notice of Objection in writing, setting out the objection and all relevant facts. Where a Notice of Objection has been served, the Council of the Municipality of Chatham-Kent shall refer the matter to the Conservation Review Board for a hearing.
