BY-LAW NO. 81-274

A BY-LAW TO DESIGNATE PROPERTY AT 189-191 ONTARIO STREET AS BEING OF ARCHITECTURAL VALUE OR INTEREST, PURSUANT TO THE PROVISIONS OF THE ONTARIO HERITAGE ACT

PASSED: November 2, 1981

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1980, Chapter 337 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

AND WHEREAS a notice of intention to designate 189-191 Ontario Street was served on the owner on the 2nd day of September, 1981 and was published in the Whig-Standard on September 2nd, 9th and 16th, 1981;

AND WHEREAS no notices of objection to the proposed designation have been served on the Clerk of the City of Kingston;

THEREFORE the Council of The Corporation of the City of Kingston enacts as follows:

- 1. There is designated as being of architectural value or interest the real property known as 189-191 Ontario Street, in the City of Kingston, as more particularly described in Schedule "A" attached hereto.
- 2. The City Solicitor is hereby authorized to cause a copy of this by-law and the reasons for designation to be registered against the land described in Schedule "A" hereto in the Registry Office at Kingston, Ontario.
- 3. The City Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the land described in

Schedule "A" hereto and on The Ontario Heritage Foundation, and to cause notice of the passing of this by-law to be published in the Whig-Standard once for each of three consecutive weeks.

4. This by-law shall come into force and take effect on its passing.

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being part of that parcel of land situate between Ontario Street and Water Lots 21 and 22 referred to as made land and Part of Water Lot 21, and more particularly described as Part 6 on Plan 13R-4129, in the City of Kingston, and in the County of Frontenac.

REASON FOR DESIGNATION OF 189-191 ONTARIO STREET,
APPROVED AT THE MEETING OF CITY COUNCIL
HELD ON OCTOBER 19, 1981 (Clause 7, Report No. 102),
AS BEING OF ARCHITECTURAL VALUE OR INTEREST

This large stone row was built for J. & W. Breden to be used for shops and offices with dwellings above. It is a good example of the type of plain but substantial building that was once at the core of the old commercial district.
