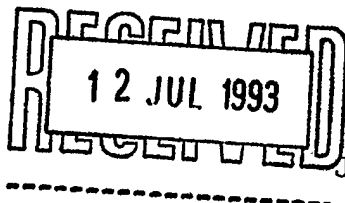

THE CORPORATION OF THE TOWNSHIP OF MARIPOSA

BY-LAW NUMBER 93-19

BEING A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS THE SOUTH PART LOT 20 CONCESSION 10 LESS RP57R2296 PART 1 AND 2, TOWNSHIP OF MARIPOSA, AS BEING OF ARCHITECTURAL/HISTORICAL VALUE AND INTEREST

WHEREAS, section 29 of the Ontario Heritage Act, 1974 authorizes the Council of the municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural/historical value/interest; and

WHEREAS, the Council of the Corporation of the Township of Mariposa has caused to be served on the owners of the lands and premises at the South Part Lot 20 Concession 10, less RP57R2296 Part 1 and 2, Township of Mariposa, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper have general circulation in the municipality once for each of three consecutive weeks;

AND WHEREAS, no notice of objection to the proposed designation has been served on the Clerk of the Municipality;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF MARIPOSA ENACTS AS FOLLOWS:

1. There is designated as being of architectural/historical value and interest the Karpazis property featuring random split fieldstone foundation, window detailing - flat arched voussoir and quoining on both sides, arched carriage entrance, seven panelled front door is flanked by side lights of yellow and blue coloured glass with single panels below and capped by a transom in the same patten as the sidelights, being the South Part Lot 20 Concession 10, Less RP57R2296 Part 1 and 2, Township of Mariposa.
2. The Municipal Solicitor is hereby authorized to cause a copy of this By-Law to be registered against the property described in the proper land registry office.
3. The Clerk is hereby authorized to cause a copy of this By-Law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this By-Law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.
4. This By-Law shall come into full force and effect on the day that it is passed.

READ A SECOND TIME THIS 5TH DAY OF JULY, 1993.

READ A THIRD TIME AND PASSED THIS 5TH DAY OF JULY, 1993.
