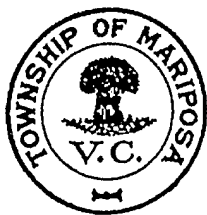

NOTICE OF INTENT TO DESIGNATE

TAKE NOTICE THAT THE Council of the Township of Mariposa hereby gives Notice of Intent to Designate the building at Concession 10 South Part Lot 20 Less RP57R2296 Part 1 and 2, Township of Mariposa, as a building of historical or architectural value or interest under the provisions of the Ontario Heritage Act.

THE REASONS FOR DESIGNATION ARE:

That this building features the following:

- random split fieldstone foundation
- window detailing - flat arched voussoir and quoining on both sides
- arched carriage entrance
- seven panelled front door is flanked by sidelights of yellow and blue coloured glass with single panels below and capped by a transom in the same pattern as the sidelights

ANY NOTICE OF OBJECTION with reasons to this designation may be served on the Clerk within thirty (30) days from May 21, 1993, being the date of the first publication of this notice.
