CORPORATION OF THE TOWNSHIP OF RAMSAY

BY-LAW 1747

A By-law to designate the premises known municipaly as Part of the Southwest Half of Lot 23, Concession 8, Township of Ramsay, as being of Architectural and Historical value and interest.

WHEREAS The Ontario Heritage Foundation Act, R.S.O. 1980, Chapter 337, authorizes the Council of a municipality to enact by-laws to designate real property including all buildings and structures thereon to be of architectural value or interest: and

WHEREAS the Council of the Corporation of the Township of Ramsay has caused to be served on the owners of the dwelling situated on Part of the Southwest Half of Lot 23, Concession 8, Township of Ramsay, and upon The Ontario Heritage Foundation notice of intention to so designate the aforesaid real property and have caused such notice of intention to so designate, to be published in the same newspaper having general circulation in the municipality, once a week for three consecutive weeks: and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality,

THEREFORE the Council of the Corporation of the Township of Ramsay enacts as follows:

- 1. There is designated as being of architectural and historical value of interest, the real property known as Part of the Southwest Half of Lot 23, Concession 8, Township of Ramsay.
- 2. The municipal Solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described, in the proper land Registry Office.
- 3. The Clerk is hereby authorized to cause a copy of this By-law to the served on The Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the same newspaper having general circulation in the municipality, once a week for three consecutive weeks.
- 4. That Schedule "A" hereto attached shall form part of this by-law.

SCHEDULE "A"

SHORT STATEMENT OF REASONS FOR THE PROPOSED DESIGNATION

The Gatehouse at the entrance to the Mill of Kintail is worthy of designation due to its historical significance and certain architectural features. Its original owner was John Baird, enterprising pioneer and operator of the original Woodside Mills now the Mill of Kintail. It was later purchased and renovated by Robert Tait Mckenzie internationally reowned sculptor, surgeon and physical educator. The building, of coursed rubbled sand stone, is a good example of Lanark County store vernacular.
