BY-LAW NUMBER 90-194

Being a By-Law to amend By-Law Number 84-52

WHEREAS pursuant to Section 29 of the Ontario Heritage Act, R.S.O. 1980, Chapter 337, The Corporation of the Town of Huntsville designated the real property described as follows:

Part of Lot 3 on the East side of King Street according to Plan 1 for the Town of Huntsville, District Municipality of Muskoka, designated as Part 1 on Plan 35R-7904
