

CORPORATION OF THE VILLAGE OF LANARK BYLAW # 86-16

BEING A BYLAW TO DESIGNATE THE PROPERTY KNOWN AS 87 CLARENCE STREET LANARK AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR INTEREST

WHERAS Part IV of The Ontario Heritage Act, Chapter 327 R.S.O. 1980 authorizes the Council of a Municipality to enact bylaws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and

WHEREAS The Council of the Corporation of the Village of Lanark has caused to be served on the owners of the land and premises known as 87 Clarence Street, Lanark and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having circulation in the municipality once for each of three consecutive weeks, and

WHEREAS the reasons for designation are set out in Schedule B hereto, and

WHEREAS no notice of objection to the proposed designation has been served on the clerk of the municipality;

THEREFORE, the Council of the Corporation of the Village of Lanark enacts as follows:

- (1) There is designated as being of architectural and historical value and interest the real property known as 87 Clarence Street Lanark, more particularly described in Schedule A hereto.
- (2) The municipal solicitor is hereby authorized to cause a copy of this bylaw to be registered against the property described in Schedule A hereto in the proper land registry office.
- (3) The Clerk is hereby authorized to cause a copy of this bylaw to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this bylaw to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

Read a first, second, and third times and passed this 5th day of August, 1986.

SCHEDULE "A" TO BYLAW # 86-16

Property Designated:

87 Clarence Street, Lanark, described as the west half of the east half of Part Lot 7, Plan 320, Village of Lanark.

SCHEDULE "B"
TO BYLAW # 86-16

Reasons for Designation:

The inherent cultural and historical significance as a valuable Lanark heritage in its original condition since it was built circa 1880;

The architectural significance of the veranda, because of its unique fretwork, decorative carving and sloping floor;

Lanark's noted carriage maker, cabinet maker and carpenter Mr. James Drysdale, was probably its builder. (Reference: Local Directory, 1884, Public Archives of Canada);

This house is the first of only two (2) houses left on Clarence Street East after the village-wide fire of 1959.
