NOTICE OF INTENTION TO PASS A BY-LAW TO DESIGNATE 927 PURDY'S MILL ROAD & 1080 SYDENHAM ROAD, ALSO KNOWN AS CATARAQUI CEMETERY NATIONAL HISTORIC SITE, TO BE OF CULTURAL HERITAGE VALUE AND INTEREST PURSUANT TO THE PROVISIONS OF THE ONTARIO HERITAGE ACT (R.S.O. 1990, Chapter O.18)

TAKE NOTICE that the Council of The Corporation of the City of Kingston intends to pass a by-law under Section 29 of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18, to designate the lands at 927 Purdy's Mill Road and 1080 Sydenham Road, (Part of Lot 16, Concession 3, former Township of Kingston, City of Kingston) also known as the Cataraqui Cemetery, to be of cultural heritage value and interest.

927 Purdy's Mill Road and 1080 Sydenham Road, also known as the Cataraqui Cemetery, (Part of Lot 16, Concession 3, former Township of Kingston, City of Kingston) is of cultural heritage value and interest because it is an early, rare, and representative example of a 19th century Rural Cemetery in Canada. The physical/design value of the cemetery is supported by a number of built structures including a mid 19th century gothic cottage; two receiving vaults; two sets of entranceway gates and pillars; its markers and monuments; its 19th century cut limestone steps and concrete bridges; as well as numerous late 19th century statues, fountain, vases and flower pots.


The gravesites found within the cemetery provide important insight into the lives of Kingston's inhabitants and reflect the key historical themes in the development of the city, the province and the nation. Further historical/associative value is derived from the large number of prominent local, provincial, and national figures who were interred in the cemetery, including Sir Alexander Campbell and Sir John A. Macdonald.

The cemetery has contextual value because of its physical relationship to the former Village of Cataraqui. Its proximity to other early 19th century burial grounds and structures link the property functionally, visually, and historically with its surroundings. These combined elements make the Cataraqui Cemetery a Kingston landmark.

WINTER REMINDERS

Be safe around snow plows.

Drivers: Stay three car-lengths behind a snow plow to allow for a safe stopping distance. NEVER cut off a snow plow.

Pedestrians and parents:

- Assume the snow plow driver has NOT seen you.
- If you see a snow plow, move off the sidewalk and into a yard where you can be seen.
- Do NOT play on, or make forts or tunnels in roadside snow banks.
- NEVER approach a snow plow, even when it has stopped.

Winter Waste Placement

Place garbage and recycling where it can be clearly seen and safely collected. Choose a collection area at a **safe** and **visible** ground-level location, such as:

- the right side at the end of your driveway (as you face the street),
- if you do not have a driveway, place it on the boulevard closest to the curb,
- or, if there is no boulevard, place it on the right side at the end of your walkway.

Keep a path from the road to your collectibles clear of snow and ice. Safe placement of collectibles helps avoid worker injury. To ensure worker safety, please remove bungee cords and other tie-downs from Green Bins and garbage cans set at the curb.

MAKE HYDRANTS VISIBLE: We thank citizens who take the time to clear snow and ice from fire hydrants, providing access to fire fighters in case of emergency.

PREVENT WATER FROM FREEZING AROUND ELECTRICAL LINES:

Ice can build up where overhead electrical service wires attach to your home – a dangerous and costly situation. Keep your eavestroughs free of debris so water runs safely away before it freezes. Consider that the root of the problem may be poor attic insulation.

NOTICE OF INTENTION TO PASS A BY-LAW TO AMEND BY-LAW NO. 8913 TO REFLECT THE CULTURAL HERITAGE VALUE AND INTEREST OF 610 MONTREAL ST., ALSO KNOWN AS THE DEPOT SCHOOL, PURSUANT TO THE PROVISIONS OF THE ONTARIO HERITAGE ACT (R.S.O. 1990, Chapter O.18)

TAKE NOTICE that the Council of The Corporation of the City of Kingston intends to pass an amending By-law under the **Ontario Heritage Act, R.S.O. 1990, Chapter O.18**, to amend By-law No. 8913 to update the Reasons for Designation for the property at 610 Montreal St., known as the Depot School, (Plan C-22 Lot 198 Pt Lots 197 196 B119).

610 Montreal St. (Plan C-22 Lot 198 Pt Lots 197 196 B119) is located at the corner of Montreal and Railway Streets in Kingston. The main building on this property, known as the Depot School, is of physical/design value for its high degree of craftsmanship and merit. This value is exhibited by the simple design of this rectangular limestone structure which was influenced by the c. 1860s Province of Canada guidelines for schools. This value is further supported by: the main building's symmetrical fenestration; front-gable roof; and more decorative elements found primarily on the building's façade, including round-arched 6/6 windows, verge brackets, and an original 6-panel wood door with a fanlight transom and an ornate ashlar hood mould. 610 Montreal St. is of historical/associative value because it has direct connections to Kingston's early school system, the City's railway history, a former community known as Grand Trunk village, and a well known local architect John Power. The contextual value of this property is derived from its prominent location at the intersection of two main traffic arteries, Montreal and Railway Streets. The property helps to define this intersection and its adjacent view planes. The Depot School's visibility is enabled by the open spaces surrounding the building.
