BY-LAW NO: 95-3778

Being a By-Law to Revoke Designating
By-law NO: 83-3013, which designated
property, including lands and
building, known municipally as 5
Parry Sound Road in the Town of Parry
Sound, as being of Architectural and
Historical Value.

WHEREAS Section 32, Part IV, of the Ontario Heritage
Act, Chapter O.18, R.S.O. 1990, permits an owner of
property, which is designated under Section 29, Part IV, to
apply to the council of the municipality in which the
property is situate, to revoke the by-law or part thereof
designating the property; and

WHEREAS the property, including lands and building,
known as 5 Parry Sound Road, in the Town of Parry Sound,
has been designated under By-law NO: 83-3013 as being of
architectural and historical value; and

WHEREAS the Council of the Corporation of the Town of
Parry Sound, on June 29th, 1995, received an application
from Shameless Harbour Properties Limited, the owner of 5
Parry Sound Road, to revoke said By-law NO: 83-3013;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE
TOWN OF PARRY SOUND ENACTS AS FOLLOWS:

1. THAT By-law NO: 83-3013, is hereby revoked.
