Re: **DESIGNATION OF THE BRIARCLIFFE  
HERITAGE CONSERVATION DISTRICT**

This is to advise you that the Council of the City of Ottawa, at its meeting of 27 February 2013, approved the following recommendations as contained in Planning Committee Report 44A, Item 1.

**That Council:**

1. **Designate the Briarcliffe Heritage Conservation District as identified in Document 1 under Section 41 of the *Ontario Heritage Act*;**
2. **Adopt the Briarcliffe Heritage Conservation District Plan as shown in Document 2; and**
3. **Direct the Planning and Growth Management Department to initiate a Zoning By-law amendment to add the Heritage Overlay (Section 60) to the area shown on Document 1.**

In addition, the Council of the City of Ottawa also passed by-law 2013-65 with reference to the above, being:

**A by-law of the City of Ottawa to designate Briarcliffe Drive and Kindle Court as a Heritage Conservation District.**
