BY-LAW NUMBER 33-98

A by-law of The Corporation of the City of Ottawa to repeal By-law Number 306-96.

WHEREAS the Council of The Corporation of the City of Ottawa designated 168-182 Sparks Street to be of historical and architectural value or interest;

AND WHEREAS a demolition permit was obtained and the buildings demolished;

AND WHEREAS the Ontario Heritage Act, R.S.O. 1990, c. O.18 authorizes a municipality to pass a by-law repealing the heritage designation of a property once the demolition of the building or structure on the property has been completed;

THEREFORE the Council of The Corporation of the City of Ottawa enacts as follows:

- 1. By-law Number 306-96 entitled "A by-law of The Corporation of the City of Ottawa to designate 168-182 Sparks Street to be of historic and architectural value or interest" is hereby repealed.
- 2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.
- 3. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owners of the property described in Schedule "A" and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Ottawa.
- 4. The City Clerk is hereby authorized to delete the property known as 168-182 Sparks Street from the register of properties designated to be of historic and architectural value or interest.
