NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Cobalt intends to designate the property, including lands and buildings, at the following municipal address as a property of architectural and/or historical value or interest under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

Municipal Address: Corner of Cobalt St. and Miller Avenue.

Reasons for the Proposed Designation:

St. Patrick's Church is recommended for designation for architectural reasons. It was constructed in two stages; a high basement in 1913 and the upper part of the walls, roof, and belfrey in 1924. Built in the tradition of early Quebec French Regime churches with its low side walls, semi-circular headed windows, and steeply pitched roof, it is a prominent and handsome landmark in the Gobalt townscape.
