### NOTICE OF THE PASSING OF A BY-LAW

TAKE NOTICE that the Council of the Corporation of the County of Prince Edward passed By-law Numbers 708-2001 and 709-2001 on August 27, 2001. These by-laws designate lands and buildings at the following municipal addresses as properties of architectural and/or historical value or interest under Part IV of The Ontario Heritage Act, R.S.O. 1990, Chapter 0.18.

- (a) WELLINGTON PUBLIC LIBRARY is described as Lot 123, Registered Plan No. 8, 261 Main Street. Wellington (Ward 3), in the Municipality of the County of Prince Edward.
- (b) PICTON PUBLIC LIBRARY is described as Lot 940, Registered Plan No. 24, 208 Main Street, Picton (Ward 1), in the Municipality of the County of Prince Edward.

#### THE CORPORATION OF THE COUNTY OF PRINCE EDWARD

BY-LAW NO. 709 -2001

A BY-LAW TO DESIGNATE THE WELLINGTON BRANCH LIBRARY TO BE OF ARCHITECTURAL AND HISTORIC VALUE AND INTEREST PURSUANT TO PART IV OF THE ONTARIO HERITAGE ACT.

WHEREAS pursuant to the Ontario Heritage Act, R.S.O. 1990 c. O.18 the Council of a municipality may by by-law designate a property including buildings and structures thereon to be of architectural or historic value and interest;

AND WHEREAS Notice of Intention to designate the property known as the Wellington Branch Library has been published and served in accordance with the provisions of the Ontario Heritage Act, R.S.O. 1990 and no notice of objection to the proposed designation has been received;

**NOW THEREFORE** the Council of the Corporation of the County of Prince Edward enacts as follows:

- 1. THAT the property known as the Wellington Branch Library and more particularly described in Schedule "A" attached hereto and forming part of this by-law is hereby designated as being of architectural and historical value and interest for the reasons set out in Schedule "B" attached hereto and forming part of this by-law.
- 2. THAT the Clerk of the Corporation of the County is hereby authorized and directed to cause a copy of this by-law to be registered in the proper Land Registry office upon the title to the property described in Schedule "A" attached hereto.
- 3. The Clerk of the County is hereby authorized and directed to cause a copy of this bylaw to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause the notice of the passing of this by-law to be published in accordance with the Ontario Heritage Act, R.S.O.1990 c.O.18 and to enter the description of the aforesaid property in the Register of all properties designated under the Ontario Heritage Act, R.S.O.1990 c. O.18.
- 4. THAT the provisions of this by-law shall come into force and effect on the day of final passing thereof.

## SCHEDULE "B" TO BY-LAW NO. 709 - 2001

## Reasons for Designation

The Wellington Library is worthy of designation based on its historical context. The connection to Parry Saylor, a County native who became an internationally acclaimed businessman and doctor, as well as W. W. Fitzgerald in its construction and design are notable and important. It contributes greatly to the civic fabric of the Wellington community and to the flavour of Main Street Wellington. The Library is sited across from the original Town Hall to establish the civic centre of Wellington, both physically and symbolically. The local interpretation and execution of library architecture is also important.

## Specific Designation Features - Wellington Library

#### Context

Contribution to the neighbourhood character —

Relationship to the adjacent properties – note the planting of the front trees in inappropriate locations. The building and site must retain its integrity.

### Architectural Considerations

Exterior – Building Envelope including north (street), east and west facades, roof structure, scale and form of the total mass

Architectural Elements – portico including ionic columns, articulated corners, windows, chimney, materials, dentil moulding, brick

Interior - upper level floor plan, ceiling heights,

Architectural Elements – mill work, fireplace with lights and accessories, original ceiling light fixtures, picture of Annie Saylor.
