NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the County of Prince Edward intends to designate the lands and buildings at the following municipal address as a property of architectural and historical interest under Part IV of the Ontario Heritage Act.

(a)  
VanAlstine's Mill - Pt. Lots 6 & 7, Conc. I South of the Bay of Quinte, North Marysburgh Township, County of Prince Edward.

VanAlstine's Mill is worthy of designation on both historical and architectural grounds.


The stone mill at Glenora is the oldest surviving grist mill in Prince Edward and the only one of stone remaining in the County. Peter VanAlstine, its builder, was an important personage, both as a local leader and as first member of the Legislature representing the area.

Architecturally the building is a very good example of the functional tradition and typifies the mill structure of the early nineteenth century with its multi-storey gabled form, heavy masonry walls in random-coursed rubble of limestone and substantial internal timber structure.

The grist mill is part of a noteworthy complex forming a dominant water side grouping of outstanding scenic value.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the County of Prince Edward before the 20th day of June, 1983.
