BY-LAW # 896/81

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS LOT 90, PLAN 2RM AND LOT 93, CONCESSION 1, AS BEING OF ARCHITECT-URAL AND/OR HISTORICAL VALUE OR INTEREST.

WHEREAS section 29 of The Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and

WHEREAS the Council of the Corporation of the Township of Ameliasburgh has caused to be served on the owners of the lands and premises known as

(a) Lot 90 Plan 2RM, Township of Ameliasburgh - S.S.# 12

The Old School at Ameliasburgh c:1890, is an essential part of the village epitomizing The Old Country School House.

(b) Lot 93, Concession 1, Township of Ameliasburgh
Albury Church

Albury Church is principally of note for the architectural composition of the exterior, its exterior details and materials and for the interior of the church proper and its finishes and furniture. The building is also historically significant for its non-denomination background.
