CITY OF TORONTO

BY-LAW No. 622-2002

To designate the area bounded generally by Hazelton Avenue, Scollard Street, Bay Street and Davenport Road, including Webster Avenue, (Yorkville-Hazelton Avenue Area) as a Heritage Conservation District.

WHEREAS City Council, at its meeting of May 11 and 12, 1999, adopted Clause No. 4 of Toronto Community Council Report No. 7, and in so doing authorized the passing of a by-law under section 40 of the *Ontario Heritage Act* defining the Hazelton Avenue area as an area to be examined for future designation as a heritage conservation district; and

WHEREAS City Council, at its meeting of May 11 and 12, 1999, passed By-law No. 267-1999 defining the study area; and

WHEREAS a heritage study of the area was subsequently conducted; and

WHEREAS under section 41 of the *Ontario Heritage Act*, no property designated under Part IV of the Act can be designated as part of a heritage conservation district;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. Subject to section 2, the area within the heavy lines shown on the map attached as Schedule "A" is designated as a heritage conservation district under Part V of the Ontario Heritage Act, R.S.O. 1990, chapter O.18, as amended.
- 2. The properties shown as "Excluded Lands" on the map attached as Schedule "A", which properties are more particularly described in the following by-laws which designate the properties under Part IV of the Ontario Heritage Act, are excluded from the heritage conservation district created under section 1:
 - A. By-law No. 56-81 of the former City of Toronto.
 - B. By-law No. 664-89 of the former City of Toronto.
- 3. This by-law shall come into force upon approval by the Ontario Municipal Board.


