- No need for observation towers, expense.
- No need for visitors to go on site. Samples of Queenston Shale can be provided for people to touch and feel.
- Shuttle service "What local sites? Already completely saturated."
- This is an ANSI provincially significant. The whole property should be preserved for Study. Nature Reserve not Escarpment Access.
- Create a vision. Determine what the site can handle. Restrict/control visitation. Connect to tourism, make it a viable venture and bring in revenue. Get outside the box views from alternate points. Don't plan in isolation to all issues.
