

### PUBLIC NOTICE - NOTICE OF THE PASSING OF A HERITAGE CONSERVATION DISTRICT DESIGNATION BY-LAW TO ADOPT A HERITAGE CONSERVATION DISTRICT PLAN

#### BY-LAW NO. 2017- 212 (UNDER THE ONTARIO HERITAGE ACT, R.S.O. 1990, C.O.18)

**TAKE NOTICE** that on October 24, 2017, the City of Kawartha Lakes adopted By-law 2017- 212, which designates Downtown Lindsay as a Heritage Conservation District (area shown on attached map) under Part V of the Ontario Heritage Act, and adopts the Downtown Lindsay Heritage Conservation District Plan.

The complete by-law, Heritage Conservation District Plan the background Study are available for inspection in Economic Development during regular business hours at 180 Kent Street West, Lindsay, between the hours of 8:30 a.m. and 4:30 p.m.

**AND TAKE NOTICE THAT** any person or agency may appeal to the Ontario Municipal Board in respect of the By-Law by filing a Notice of Appeal with the Office of the City Clerk, City of Kawartha Lakes, no later than 4:30 p.m. on December 4, 2017, setting out the objection to the By-law and the reasons in support of the objection. The Notice of Appeal must be made using an "Appellant Form" available from the Ontario Municipal Board website at [www.omb.gov.on.ca](http://www.omb.gov.on.ca). The appeal must be accompanied by a certified cheque or money order made payable to the Minister of Finance in the amount of \$ 300.00 for each appeal.

The By-law will come into force on December 5, 2017, if no notice of appeal is received on or before December 4, 2017.

No person or agency shall be added as a party to the hearing of an appeal unless, before the By-Law was passed, the person or agency made oral submissions at a public meeting or written submissions to The City of Kawartha Lakes Council or, in the opinion of the Ontario Municipal Board, there are reasonable grounds to add the person or agency as a party.
