BY-LAW NO. 2 OF 1982

A By-law to designate an area of the Town of Goderich as a Heritage Conservation District under Section 41 (1) of The Ontario Heritage Act, 1974, S.O. 1974, c. 122 as amended.

WHEREAS Part V of The Ontario Heritage Act, 1974 S.O. 1974, c. 122 as amended contains provisions relating to heritage conservation districts.

AND WHEREAS Council under Section 40 of Part V of the said Ontario Heritage Act has by by-law defined 'The Square' as an area to be examined for future designation as a heritage conservation district.

AND WHEREAS the examination of 'The Square' has now been completed.

AND WHEREAS under Section 41 of the said Ontario Heritage Act where there is in effect in a municipality an official plan that contains provisions relating to the establishment of heritage conservation districts Council may by by-law designate any defined area as a heritage conservation district.

AND WHEREAS there is in effect in the Town of Goderich an official plan that contains provisions relating to the establishment of heritage conservation districts.

NOW THEREFORE the Council of the Town of Goderich ENACTS as follows:



1. The area known locally as 'The Square' more particularly the area bounded by Elgin Street, Victoria Street, Nelson Street and Waterloo Street as shown on Schedule "A" attached hereto is hereby designated as a Heritage Conservation District;
2. Schedule "A" is hereby declared to be part of this By-law;
3. This By-law comes into effect on the date of passage subject to receiving the approval of the Ontario Municipal Board.

READ A FIRST AND SECOND TIME THIS 4TH DAY OF JANUARY , 1982.

READ A THIRD TIME AND FINALLY PASSED THIS 18TH DAY OF JANUARY , 1982.
