NOTICE OF PARTIAL REPEAL OF BY-LAW

TAKE NOTICE that the Council of The Corporation of the City of  
Ottawa on the 2nd day of July 1987, enacted By-law Number 150-87 thereby  
partially repealing By-law Number 41-78 which designated the lands and  
buildings known as The Billings Estate as a property of historic and  
architectural value or interest under the Ontario Heritage Act. The  
repeal applies to the vacant lands which form part of the new residential  
subdivision on the Billings Estate.

A by-law of The Corporation of the City of Ottawa to repeal part of By-law Number 41-78.

WHEREAS the Ontario Heritage Act, R.S.O. 1980, Chapter 337 authorizes the Council of the municipality to enact a by-law to designate real property, including all buildings and structures thereon, to be of historic or architectural value or interest;

AND WHEREAS the Council of The Corporation of the City of Ottawa enacted By-law Number 41-78 entitled "A by-law of The Corporation of the City of Ottawa to designate 2100 Cabot Street", on the 15th day of February, 1978;

AND WHEREAS Section 32 of the said Ontario Heritage Act further authorizes the Council of the municipality to repeal part of a by-law which designated property;


THEREFORE the Council of The Corporation of the City of Ottawa enacts as follows:

1. That part of By-law Number 41-78 which applies to the property described in Schedule "A" hereto, is hereby repealed to the extent only of the property described in Schedule "A".
2. The said By-law Number 41-78 is hereby reconfirmed as it applies to the property described in Schedule "B" hereto.
3. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the properties described in Schedules "A" and "B" hereto, in the proper Land Registry Office.
4. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owners of the properties described in Schedules "A" and "B", and upon the Ontario Heritage Foundation, and to cause notice of this by-law to be published in a newspaper having a general circulation in the City of Ottawa.

5. The schedules attached hereto and marked Schedule "A" and Schedule "B" form part of this by-law and all notations, references and other information contained therein shall be as much a part of this by-law as if all the matters and information set forth by the said schedules were all fully described herein.
