## THE CORPORATION OF THE TOWNSHIP OF NORTH DUMFRIES

## BY-LAW NUMBER 2633-14

Being a By-law to designate a Heritage Conservation District, and to adopt a Heritage Conservation District Plan for the area of the municipality known as the Greenfield settlement area.

WHEREAS the Township's Official Plan contains provisions relating to the establishment of Heritage Conservation Districts;

WHEREAS the Council has consulted with the North Dumfries Municipal Heritage Committee with respect to the Greenfield Heritage Conservation District Plan dated March 2014 (the "Plan");

WHEREAS appropriate notice of the public meeting to discuss the proposed Plan was given;

WHEREAS the proposed Plan was made available to the public and a public information meeting with respect to the Plan was held on February 13<sup>th</sup>, 2014; the statutory Public Meeting was held on March 24<sup>th</sup>, 2014;

AND WHEREAS Council for the Township has received the Plan at the meeting held March 24<sup>th</sup>, 2014, and has authorized staff with the intention to implement any or all of the policies of the Plan to conserve the village of Greenfield;


NOW THEREFORE, Township Council enacts as follows:

- 1. The area outlined by the dashed lines on the map attached as Schedule "A" to this by-law and entitled "Greenfield Heritage Conservation District" is hereby designated as the "Greenfield Heritage Conservation District".
- 2. The Plan attached hereto as Schedule "B" and forming part of the by-law is hereby adopted by Council as the "Greenfield Heritage Conservation District Plan" and is to be used as a guidance document
- 3. The Clerk is hereby authorized to cause notice of this by-law to be given, to cause the bylaw to be registered in the appropriate land registry office, and to update the Township Heritage registry, all as required by the Ontario Heritage Act.
- 4. This By-law shall come into force and take effect in accordance with the provisions of the Ontario Heritage Act.
