

THE CORPORATION OF THE TOWN OF MARKHAM  
BY-LAW NO. 343-86

A by-law to define an area to be examined for future designation as a heritage conservation district.

WHEREAS Section 40 of the Ontario Heritage Act, R.S.O., 1980, c. 337 enables the council of a municipality to define an area to be examined for future designation as a heritage conservation district;

AND WHEREAS the Official Plan of the Town of Markham Planning Area contains provisions for the designation of heritage conservation districts;


AND WHEREAS the Council of the Town of Markham has consulted with its Local Architectural Conservation Advisory Committee on the definition of an area to be examined for future designation as a heritage conservation district;


NOW THEREFORE the Council of the Corporation of the Town of Markham enacts as follows:

READ a third time and passed this 14th day of October, 1986

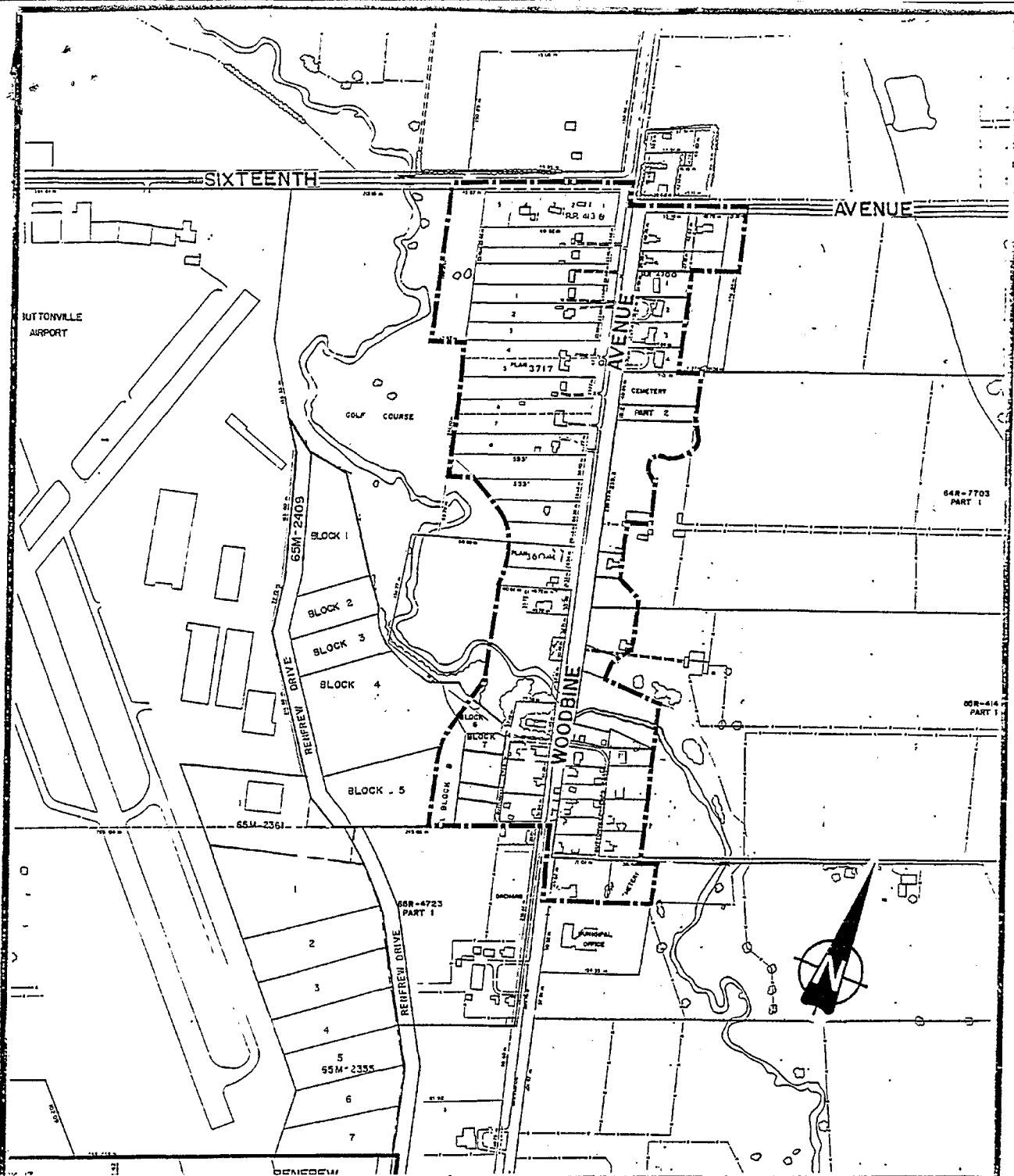
