NOTICE OF ADOPTION OF BY-LAW NO. 1329-2015 (Under the Ontario Heritage Act, R.S.O. 1990, c.O.18)

West Annex Phase 1 (Madison Avenue) Heritage Conservation District

TAKE NOTICE that on December 10, 2015, Toronto City Council enacted By-law 1329-2015, which designates the West Annex Phase I (Madison Avenue) Heritage Conservation District (area shown on attached map) under Part V of the Ontario Heritage Act. The by-law also adopts the West Annex Phase I (Madison Avenue) Heritage Conservation District Part II Plan, dated May 2015 as the district plan for the West Annex Phase I (Madison Avenue) Heritage Conservation District.

Any person who objects to the By-law may appeal to the Ontario Municipal Board by filing a notice of appeal with the City Clerk, Attention: Rosalind Dyers, Administrator, Toronto and East York Community Council, Toronto City Hall, 100 Queen Street West, 2nd Floor West, Tower, Toronto, Ontario, M5H 2N2, no later than **February 5, 2016**.

A Notice of Appeal must:

- 1. set out the objection and the reasons in support of the objection; and
- 2. be accompanied by the fee prescribed under the Ontario Municipal Board Act in the amount of \$125 payable by cheque to the Minister of Finance, Province of Ontario.

The By-law will come into force on December 10, 2015, if no notice of appeal is received on or before February 5, 2016.

Explanatory Note:

District Designation By-Law

On December 9 and 10, 2015, Toronto City Council adopted By-law No. 1329-2015, which designated the area shown on the map attached to this notice as the West Annex Phase I (Madison Avenue) Heritage Conservation District (the District) under Part V of the Ontario Heritage Act (the Act). The By-law also adopts the Heritage Conservation District Plan, dated May 2015.

Alterations to Property

The purpose of By-law No.1329-2015 is to maintain the heritage character of the West Annex Phase I (Madison Avenue) Heritage Conservation District. This is accomplished by requiring certain alterations to buildings within the District to conform to District Policies and Guidelines which are included in the District Plan. Typically, these alterations only relate to portions of the property that are visible from the street (i.e., the façade). For example, no heritage permit is required for exterior work that is not visible from the street, interior work, painting, and repairs using the same materials. If the proposal conforms to the District Policies and Guidelines it can be approved by staff. Applications that do not conform to the District Policies and Guidelines will be referred to City Council for consideration.

Demolition and Infill Development


Under By-law 1329-2015, owners of property are required to apply for a heritage permit before demolishing any building in the District. Demolition applications are referred to City Council for consideration. If City Council refuses the permit, the applicant may appeal to the Ontario Municipal Board. New (infill) construction must contribute to the heritage character of the District, as per the District guidelines.

CITY OF TORONTO

BY-LAW No. 1329-2015

To designate the West Annex Phase 1 (Madison Avenue) Heritage Conservation District and adopt the West Annex Phase 1 (Madison Avenue) Heritage Conservation District Part II Plan.

Whereas City Council has authorized the establishment of the West Annex Phase 1 (Madison Avenue) Heritage Conservation District and the adoption of the West Annex Phase 1 (Madison Avenue) Heritage Conservation District Part II Plan;

The Council of the City of Toronto enacts:

- 1. The area outlined by the heavy lines shown on the map attached as Schedule "A" and described in Schedule "B" to this by-law is designated as a heritage conservation district under Part V of the *Ontario Heritage Act*, to be known as the West Annex Phase 1 (Madison Avenue) Heritage Conservation District.
- 2. The West Annex Phase 1 (Madison Avenue) Heritage Conservation District Part II Plan, dated May 2015, is adopted as the district plan for the West Annex Phase 1 (Madison Avenue) Heritage Conservation District.
- 3. A copy of the West Annex Phase 1 (Madison Avenue) Heritage Conservation District Part II Plan is available for inspection at the offices of the City of Toronto Planning Division, Heritage Preservation Services, City Hall, 100 Queen Street West, Toronto, Ontario and on the City's web site at: www.toronto.ca/heritage-preservation/heritage_districts.htm.
- 4. The City Clerk is authorized to cause a copy of this by-law to be served upon the owners of property located in the West Annex Phase 1 (Madison Avenue) Heritage Conservation District as set out in Schedule "B" to this by-law and on the Ontario Heritage Trust, and to cause notice of this by-law to be posted on the City's web site for a period of 30 days in accordance with Municipal Code Chapter 162, Notice, Public, Article II, § 162-4.1. Notice requirements under the *Ontario Heritage Act*.
- 5. The City Solicitor is authorized to cause a copy of this by-law to be registered against title to the properties described in Schedule "B" to this by-law in the proper Land Registry Office upon the coming into force of this by-law.


