NOTICE OF INTENTION TO DESIGNATE

Take notice that the Council of the Corporation of the City of Brantford, on the 21st day of November 1994, decided to designate the lands and/or buildings known as 34 and 36 Palace Street as properties of historical and/or architectural value or interest under the Ontario Heritage Act, 1990, R.S.O., Chapter 0.18, but that designation be limited to the exterior of the building at 34 and 36 Palace Street.

**SHORT STATEMENT OF THE REASONS
FOR THE PROPOSED DESIGNATION**

The properties municipally known as 34 and 36 Palace Street are located on the northeast corner of Palace Street and Albion Street. This residential building, constructed Circa 1870, is a fine example of Italianate architecture and typical of the style used for many prominent Brantford homes of that era. Originally constructed as a single dwelling, the residence was divided into two dwellings in 1906.

This dwelling has a historical link to the Nelles family who were United Empire Loyalists. Rev. Abram Nelles was a missionary on the Six Nations Reserve and principal of the Mohawk Institute. When Rev. Nelles retired in 1879, he had completed fifty years of service to the Six Nations Indians and resided at 34 Palace Street until his death. Rev. Nelles and several members of his family are buried at Her Majesty's Chapel of the Mohawks.

Notice of the objections to the designation may be served on the City Clerk within thirty days of the 1st day of December, 1994.
