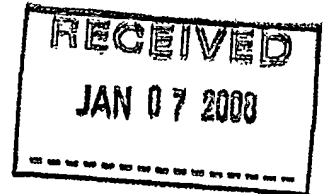

NOTICE OF PASSAGE OF THE

DOWNTOWN ARNPRIOR HERITAGE CONSERVATION DISTRICT BY-LAW

IN THE MATTER OF THE

Ontario Heritage Act

The Town of Arnprior, on November 13, 2007, passed By-law No. 5577-07 designating a portion of Downtown Arnprior as a heritage conservation district under Part V of the *Ontario Heritage Act*.

Any person who objects to the By-law may appeal to the Ontario Municipal Board by giving the Clerk of the Town of Arnprior, within 30 days after the date of publication of this ad, notice of appeal setting out the objection to the By-law and the reasons in support of the object, accompanied by the fee prescribed under the *Ontario Municipal Board Act*.
