## THE CORPORATION OF THE TOWN OF GODERICH

### BY-LAW NO. 59 OF 2014

---

#### A BY-LAW TO AMEND THE SQUARE HERITAGE CONSERVATION DISTRICT IN THE TOWN OF GODERICH

---

**WHEREAS**, pursuant to By-law 2 of 1982, the Council of the Corporation of the Town of Goderich designated the area of the Town bounded by Elgin Street, Victoria Street, Nelson Street and Waterloo Street, locally known as "The Square" as a Heritage Conservation District pursuant to Section 40 of the *Ontario Heritage Act*, RSO 1990;

**AND WHEREAS**, the designated area was reduced in size by the Ontario Municipal Board;

**AND WHEREAS**, pursuant to Subsection 41.1(2) of the *Ontario Heritage Act*, the Council of a Municipality must adopt a Heritage Conservation District Plan for each district that is designated in a By-law;

**AND WHEREAS**, it has been recommended in the Heritage Conservation District Study prepared for the Town that The Square Heritage Conservation District be expanded to include properties at 36 Kingston Street and 37 Kingston Street;

**AND WHEREAS**, Council considers it in the interests of the Town to expand The Square Heritage Conservation District as recommended;

#### **NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF GODERICH ENACTS AS FOLLOWS:**

1. The Square Heritage Conservation District is hereby expanded to include 33 Kingston Street and 37 Kingston Street.
2. Schedule "A" attached hereto is hereby adopted as part of this By-law.
3. The Downtown Goderich Heritage Conservation District Plan, prepared by Bray Heritage dated June, 2014 is adopted as the Heritage Conservation District Plan for The Square Heritage Conservation District.

4. This By-law shall come into effect upon passage.
