The Council of the City of St. Catharines at its meeting of April 29th 1991, passed the above-noted by-laws.

By-law No. 91-129 was passed in order to designate an area in the City of St. Catharines as a Heritage Conservation District. Therefore, By-law Nos. 91-127 and 91-128 were passed in order to repeal By-law Nos. 78-364 and 78-365 which previously designated the Montebello Park Pavilion and the Montebello Park Band Stand, respectively, and are located in the Heritage Conservation District.

Application has been made to the Ontario Municipal Board for approval of By-law No. 91-129. By-law Nos. 91-127 and 91-128 shall come into force upon approval of the Ontario Municipal Board.

A By-law to designate an area of the City of St. Catharines as a heritage conservation district.

THE COUNCIL OF THE CORPORATION OF THE CITY OF ST. CATHARINES, pursuant to the provisions of the Ontario Heritage Act, R.S.O. 1980, c.337, as amended, enacts as follows:

- The area shown on Schedule "A" attached hereto is hereby designated as a heritage conservation district.




