

BY-LAW NO. 6085-08

BEING A BY-LAW TO DESIGNATE AN AREA OF THE TOWN OF WHITBY KNOWN AS THE BROOKLIN HERITAGE CONSERVATION DISTRICT AS A HERITAGE CONSERVATION DISTRICT PURSUANT TO PART V OF THE ONTARIO HERITAGE ACT, R.S.O. 1990, c.O.18, AS AMENDED

WHEREAS the Official Plan of the Town of Whitby Planning Area, as amended, supports the use of available legislation such as the Ontario Heritage Act, R.S.O.1990 c.O.18, as amended, to achieve heritage preservation;

AND WHEREAS Official Plan of the Town of Whitby Planning Area provides that Council shall achieve the goals, objectives and policies of section 6.1, Heritage Resources, of the Plan by applying the power to pass by-laws to examine an area for future designation as a heritage conservation district under Part V of the Ontario Heritage Act, R.S.O. 1990, c.O.18, as amended;

AND WHEREAS, the examination of the Brooklin Heritage Conservation District Study Area has now been completed and the Council of the Town of Whitby has adopted the "Brooklin Heritage Conservation District Plan" identified as the District Plan and the District Study;

AND WHEREAS, Section 41 of the said Ontario Heritage Act enables the Council of a municipality to designate, by By-law, an area as a Heritage Conservation District, where there is in effect in a municipality, an Official Plan that contains provisions relating to the establishment of Heritage Conservation Districts;

NOW THEREFORE, the Council of The Corporation of the Town of Whitby hereby enacts as follows:

1. THAT the area known as the "Brooklin Heritage Conservation District" as illustrated in Schedule "A" attached hereto, be designated as a Heritage Conservation District pursuant to Part V of the Ontario Heritage Act, R.S.O.1990,c.O.18, as amended; and,

2. THAT this By-law does not come into force until approved by the Ontario Municipal Board or no notice of appeal is given to the clerk within the time period specified in section 41.4 of the Ontario Heritage Act, R.S.O. 1990,c.O.18, as amended.
