

BY-LAW NUMBER 1690-2001-PL

BEING A BY-LAW UNDER THE PROVISIONS OF PART IV OF THE *ONTARIO HERITAGE ACT*, R.S.O. 1990, CHAPTER O.18, AS AMENDED, TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS 51 MCKAY STREET, CANNINGTON, AND DESCRIBED AS PART 1, PLAN 40R-13839, IN THE TOWNSHIP OF BROCK, IN THE REGIONAL MUNICIPALITY OF DURHAM, IN THE PROVINCE OF ONTARIO (FORMERLY IN THE VILLAGE OF CANNINGTON, COUNTY OF ONTARIO), AS BEING OF ARCHITECTURAL AND HISTORICAL INTEREST

WHEREAS section 29 of the *Ontario Heritage Act*, R.S.O. 1990, chapter O.18, as amended, authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

AND WHEREAS the Council of the Corporation of the Township of Brock has caused to be served on the owners of the lands and premises known as "Cannington Boy Scout Hall" at 51 McKay Street, Cannington, described as Part 1, Plan 40R-13839, in the Township of Brock, in the Regional Municipality of Durham, in the Province of Ontario (formerly in the Village of Cannington, County of Ontario), and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality;

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality;

NOW THEREFORE the Council of the Corporation of the Township of Brock hereby enacts as follows:

- 1. There is designated as being of architectural and historical value or interest the real property known as "CANNINGTON BOY SCOUT HALL" at 51 McKay Street, Cannington, described as Part 1, Plan 40R-13839, in the Township of Brock, in the Regional Municipality of Durham, in the Province of Ontario (formerly in the Village of Cannington, County of Ontario), more particularly described in Schedule "A" attached hereto.
- The Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered
 against the property described in Schedule "A" attached hereto in the proper land registry
 office.
- 3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality.

THIS BY-LAW READ A FIRST, SECOND AND THIRD TIME AND PASSED THIS 14TH DAY OF MAY, A.D., 2001.
