RE: Issuance of Heritage Permit for Roof Repairs at 2477 Glenwood School Drive, Burlington (File 501-06,4)

The Director of Planning and Building has issued the requested heritage permit concerning the repairs to the roof, as required pursuant to the *Ontario Heritage Act*, under authority delegated to staff by Council. The "Scope of Work" form is attached. Please note that the permit only includes those items outlined in the Scope of Work. The remaining issues including the replacement shutters and kitchen addition will be addressed through separate heritage permit applications.

Please note that this application has been reviewed by both Heritage Planning staff and the Heritage Burlington Citizens Advisory Committee.

The application for a heritage permit has been reviewed using Parks Canada's Standards and Guidelines for the Conservation of Historic Places. The Standards and Guidelines provide the following recommendations:

- "Stabilizing deteriorated exterior walls by using structural reinforcement, weather protection, or correcting unsafe conditions, as required, until repair work is undertaken"
- "Repairing parts of exterior walls by patching, piecing-in, consolidating, or otherwise reinforcing, using recognized conservation methods. Repair may also include the limited replacement in kind, or with a compatible substitute material, of extensively deteriorated or missing parts of the exterior wall assembly. Repairs should match the existing work as closely as possible, both physically and visually"
