CORPORATION OF THE TOWN OF WALKERTON

BY-LAW NUMBER 82-36

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN  
MUNICIPALLY AS THE SOUTH WEST CORNER OF  
COLBORNE AND JANE STREETS  
AS BEING OF ARCHITECTURAL AND HISTORICAL  
VALUE OR INTEREST

WHEREAS section 29 of The Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest; and


WHEREAS the Council of the Corporation of the Town of Walkerton has caused to be served on the owners of the lands and premises known as St. Thomas' Anglican Church at the south west corner of Colborne and Jane Streets and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS no notice of objection to the proposed designation has been served on clerk of the municipality;

THEREFORE the Council of the Corporation of the Town of Walkerton enacts as follows:


- 1) There is designated as being of architectural and historical value or interest the real property known as St. Thomas' Anglican Church at the south west corner of Colborne and Jane Streets, more particularly described in Schedule A hereto.
- 2) The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule A hereto in the proper land registry office.
- 3) The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.





All and singular that certain parcel or tract of land and premises situated, lying and being in the Town of Walkerton in the County of Bruce and Province of Ontario, being composed of lots numbers one (1) and two (2) in Carroll's registered plan number one hundred and sixty-two (162) of subdivision of Park Lot number eight (8) west of Victoria Street containing by measurement two (2) roods ( $\frac{1}{2}$ .acre) be the same more or less.
