## **NOTICE OF INTENTION TO REPEAL A BY-LAW**

TAKE NOTICE that the Council of the Corporation of the Town of Walkerton intends to repeal the By-law designating the property, including lands and buildings, at the following municipal address as having architectural and/or historical value or interest so that the property will no longer be deemed to be of architectural and/or historical value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1990, c.0.18 as amended. The owner of this structure being the Corporation of the Town of Walkerton has by way of resolution #97-17-172 dated May 5<sup>th</sup>, 1997 requested that the designating by-law for the Victoria Jubilee Hall be repealed.

**Victoria Jubilee Hall in the Town of Walkerton** shall no longer be designated pursuant to Section 31 of the Ontario Heritage Act, R.S.O. 1990, c.0.18 as amended. This structure is located at 111 Jackson Street at the south west corner of the intersection of Jackson Street south and Scott Street. The legal description for the property that is subject to the designation is Lot 56 and Part of Lots 54, 55 and 57 south side of Scott Street, Registered Plan No. 7, Town of Walkerton in the County of Bruce. The Victoria Jubilee Hall is a 2½ storey 14,276 square foot structure which was built in 1897. It has a stone and concrete foundation, wood timber frame, 3 ply brick walls, stone veneer front and a slate roof complete with a cupola.

Any person may, within thirty (30) days after the date of first publication of this Notice, send by registered mail or deliver to the Clerk of the Corporation of the Town of Walkerton a notice of his or her objection to the proposed repeal of the By-law together with a statement of the reasons for the objection and all relevant facts. If such a notice of objection is received, the Council of the Corporation of the Town of Walkerton shall refer the matter to the Conservation Review Board for a Hearing.
