BEING A BY LAW TO LESIGNATE 10 KING STREET, GANANOQUE, TO BE OF HISTORICAL SIGNIFICANCE

WHEREAS the Ontario Heritage Act, Section 29, states that the Council of a municipality may, by by-law, designate a property within the municipality to be of cultural heritage value or interest:

**AND WHEREAS** the Committee of the Whole reviewed COW Report-ED-2018-07, and concurred with the recommendation to designate 10 King Street, to be *of* historical significance.

AND WHEREAS the Council of the Town of Gananoque passed Motion #18-137, authorizing staff to publish a Notice of Intention to provide a Heritage Designation to lands municipally known as 10 King Street East;

AND WHEREAS on November 26, 2018, Notice was published on the Town's website and local newspaper for two (2) consecutive weeks and served on the property owner, Ontario Heritage Trust and the Gananoque Reporter;

**AND WHEREAS** the public was provided an opportunity to object to the Notice of Intention to Designate, to the Town Clerk by January 2, 2019;

**AND WHEREAS** the Town Clerk has not received any objections to the proposed Heritage Designation as of January 2, 2019;

**AND WHEREAS** the Committee of the Whole reviewed COW Report-ED-2019-01, and concurs with the staff recommendation to proceed with the Heritage Designation to lands municipally known as 10 King Street East;

**AND WHEREAS** the Council of the Town of Gananoque deems it advisable to pass this Bylaw.

**NOW THEREFORE** the Council of the Corporation of the Town of Gananoque enacts as follows:

# 1. **AUTHORIZATION:**

1.1 That the building municipally known as 10 King Street East, be hereby designated as a property of historic and architectural value or interest.

### 2. SCHEDULE:

2.1 Attached to and forming part of this By-law is the Heritage Designation, marked as Schedule 'A'.

# 3. REGISTER ON TITLE

3.1 This By-law shall be Registered on Title, as described in Schedule 'A'.

# 4. **EFFECTIVE DATE:**

4.1 This By-law shall come into full force and effect on the date it is passed by Council.

Read a first, second and third time and finally passed this 22<sup>nd</sup> day of January, 2019.

### Description of the Property:

The former Victoria Hotel, currently used as a public library, stands on the north bank of the Gananoque River adjacent to Confederation Park and near the Town centre. It is composed of a two-storey main block facing King Street East, and a single-storey rear wing that runs along the south side of Park Street.

## Statement of Cultural Heritage Value or Interest:

Constructed in the 1840s, the two-storey brick main block has design or physical value as a relatively rare and representative example of a Classical Revival style hotel. Its balanced, 'temple' front features a central entrance flanked by large shopfront windows, symmetrical fenestration at the second level and gable, and low front gable roof with returned eaves. The design or physical value extends to the rear wing, which includes a cupola with bell cast roof.

The property has historical value and associative value not only as an early hotel in the community (originally the Albion Hotel, then Victoria Hotel) but also for its direct association with the Jones Shovel Company, a successful local company that operated in the building between 1906 and 1963. Combined, the architecture of the main block and wing defines and supports the historic commercial character of King Street East in downtown Gananoque, and serves the community as a public library.

# **Description of Heritage Attributes**

Key attributes that express the design or physical value of 10 King Street East include its:

- Combined two-storey main block and storey-and-a-half rear wing;
- Low front gable roof on the main block with returned eaves;
- Second level balcony on the King Street East frontage of the main block that is supported by decorated metal pillars;
- Symmetrical fenestration and door openings on the King Street East front (east) of the main block:
- Symmetrical fenestration and central door on the north façade of the rear wing; and,
- Cupola with a bell cast roof on the rear wing roof.

Key attributes that express the property's contextual value include its:

- Location in the centre of the Town and siting with minimal setback on a main thoroughfare;
   and.
- Visual relationships with other 19<sup>th</sup> century historic properties including the Old Foundry (9-15 King Street East) and Town Hall (30 King Street East).
