The Council of the Corporation of the City of Burlington at its regular meeting held on Monday, May 10, 1993, enacted the following resolution having reference to Planning and Development Committee Item No. PD-169-93:

THAT pursuant to the terms of the Ontario Heritage Act, R.S.O. 1990, c. O.18, as amended, the property known as 2477 Glenwood School Drive be designated as a structure of historical and architectural significance;

and that the City Clerk be authorized and directed to so notify the owners of 2477 Glenwood School Drive and the Ontario Heritage Foundation of the municipality's intention to designate;

and that the City Clerk be further directed to place the necessary advertisements and prepare the documents related thereto.

Notice of Intention to Designate

2477 Glenwood School Drive

IN THE MATTER OF THE ONTARIO HERITAGE ACT AND IN THE MATTER OF the lands in the City of Burlington known municipally as 2477 Glenwood School Drive.

NOTICE IS HEREBY GIVEN that the City of Burlington intends to designate the property known as 2477 Glenwood School Drive as being historically and architecturally significant.

A summary of the reasons for the proposed designation is set out in Schedule A to this Notice. The complete reasons for designation may be viewed in the Clerk's Department, Ground Floor, City Hall, 426 Brant Street, during regular business hours.

Any person may, within 30 days after the date of the first publication of this Notice, serve written notice of his or her objection to the proposed designation together with a statement for the objection and all relevant facts.

SCHEDULE A

Locust Lodge, built circa 1838 by James Wilson, is one of the oldest farm houses in Burlington. It was constructed of local limestone, probably by the stonemason who built two other houses on the Guelph Line at about the same time: Ireland House and the Fisher homestead, Shady Cottage.
