By-law to repeal City of Brockville By-law 59-85, Being a By-Law to Designate the Property known as "Fairview", the Willson-Page House, 40 Crawford Street, for both Historical and Architectural Reasons

WHEREAS the Council of the Corporation of the City of Brockville passed by-law 137-88 at a Regular Council Meeting held June 14th, 1988, designating the property known as "Fairview", the Willson-Page House, 40 Crawford Street, for both Historical and Architectural Reasons; and,

WHEREAS the current property owners of 40 Crawford Street have petitioned Council to repeal by-law 059-1985; and,

WHEREAS Section 32(2) of the Ontario Heritage Act allows Municipal Councils to repeal a designating by-law, providing that it publishes a notice of the intention to repeal in a newspaper of general circulation in the municipality; and

WHEREAS a Notice of Intention to repeal By-law 059-1985 was published in the Recorder and Times Newspaper on Saturday, February 28, 2015 and Thursday, March 5, 2015; and

WHEREAS an objection was filed with the City of Brockville Clerk's Office respecting the repealing of By-law 59-85 on March 30, 2015; and


WHEREAS through mediation with guidance from the Conservation Review Board, on July 9, 2015 the Objector withdrew his objection on condition that the property owner permit the property at 40 Crawford Street to be added to the municipal register of cultural heritage properties for the City of Brockville; and

WHEREAS the Conservation Review Board (File No. CRB1506) was closed on July 9, 2015;


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF BROCKVILLE ENACTS AS FOLLOWS:

- 1. THAT By-law 59-85, being a by-law to Designate the Property known "Fairview", the Willson-Page House, 40 Crawford Street, for both Historical and Architectural Reasons is hereby repealed.
