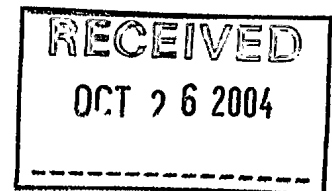

## *Notice of Intention to Designate*

IN THE MATTER OF THE ONTARIO HERITAGE ACT AND IN THE MATTER OF the lands in the City of Burlington known municipally as 310 Seneca Avenue.

NOTICE IS HEREBY GIVEN that the City of Burlington intends to designate the above-noted property as being historically and architecturally significant.

A summary of the reasons for the proposed designation set out in the Schedule A to this notice. The complete reasons for designation may be viewed in the Clerks Department, Main Floor, City Hall, 426 Brant Street, during regular business hours.

Any person may, within 30 days after the date of the publication of this Notice, serve written notice of objection to the proposed designation, together with a statement for the objection and all relevant facts.

### **SCHEDULE "A" REASONS FOR DESIGNATION 310 Seneca Avenue**

310 Seneca Avenue possesses cultural heritage value as an excellent example of an 1870's Burlington/Victorian vernacular farmhouse, and has historical associations with Dr. J. N. Anderson and Dr. Frank De Witt Bates, who were among the first physicians in Burlington. The Reasons for Designation apply to the front and south side elevation including the front facade, verandah and windows as follows.

#### **Front (East) Facade:**

- Two bay windows that contain original glass
- The full front shed-roofed verandah with a low porch railing supported by squared posts
- The projecting center gable on the second floor

#### **Side (South) Elevation:**

- The bay window with an apron clad with cedar shingles
