The Corporation of the Township of Somerville

By-law #2000-19

BEING A BY-LAW to designate the building known as the Austin Sawmill as being of architectural and historical value or interest.

WHEREAS The Ontario Heritage Act, 1990, R.S.O., Chapter 0.18 enables municipalities to enact by-laws to designate all buildings and structures thereon, to be of architectural or historical value or interest.

AND WHEREAS Council of the Corporation of the Township of Somerville has caused to be served on the owners of the lands and premises known as the Austin Sawmill located on Block O, Registered Plan 105, and upon the Ontario Heritage Foundation, notice of intention to designate the aforesaid building and has caused such notice of intention to be published in a newspaper having general circulation in the municipality as required by law.

WHEREAS no notice of objection to the proposed designation has been received by the Corporation of the Township of Somerville.


THEREFORE, the Council of the corporation of the Township of Somerville, ENACTS AS FOLLOWS:

- 1) There is designated as being of architectural and historical value or interest the building known as the Austin Sawmill situate on Block O, Registered Plan 105, more particularly described in Schedule "A" hereto.
2. The Township is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.
3. The Clerk is hereby authorized to cause a copy of this By-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this By-law to be published in a newspaper having general circulation in the Township of Somerville.





SCHEDULE A TO BY-LAW #2000-19

THAT THE AUSTIN SAWMILL BUILDING ONLY LOCATED ON THAT CERTAIN  
PARCEL OR TRACT OF LAND KNOWN AS BLOCK O, ON REGISTERED PLAN  
105 FOR THE TOWNSHIP OF SOMERVILLE IN THE COUNTY OF VICTORIA.
