# **The Corporation of the City of Kawartha Lakes**

## **By-Law 2018-171**

### **A By-Law to Repeal and Replace Town of Lindsay By-Law 1988-85, Being a By-Law to designate 45 Victoria Avenue North, Lindsay, in the City of Kawartha Lakes as being of Cultural Heritage Value and Interest**

#### **Recitals**

1. Section 29 of the Ontario Heritage Act, R.S.O. 1990, provides that the Council of a municipality may pass a by-law designating a property within the boundaries of the municipality to be of cultural heritage value or interest.
2. Notice of Intention to Designate 45 Victoria Avenue North, Lindsay City of Kawartha Lakes, described further in Schedule "A", has been given in accordance with Section 29 of the Ontario Heritage Act.
3. No objection to the proposed designation has been served on the Clerk of the City.
4. Reasons for Designation are set forth in Schedule "A".

**Accordingly, the Council of The Corporation of the City of Kawartha Lakes enacts this By-law 2018-171.**

#### **Section 1.00: Definitions and Interpretation**

##### **1.01 Definitions:** In this by-law,

**"City", "City of Kawartha Lakes" or "Kawartha Lakes"** means The Corporation of the City of Kawartha Lakes and includes its entire geographic area;

**"City Clerk"** means the person appointed by Council to carry out the duties of the clerk described in section 228 of the Municipal Act, 2001;

**"Council" or "City Council"** means the municipal council for the City;

**"Director of Development Services"** means the person who holds that position and his or her delegate(s) or, in the event of organizational changes, another person designated by Council;

**"Property"** means property as set out in Section 2.01.

##### **1.02 Interpretation Rules:**

- (a) The Schedules attached to this by-law form part of the by-law, and are enforceable as such.

- (b) The words "include" and "including" are not to be read as limiting the meaning of a word or term to the phrases or descriptions that follow.

- 1.03 **Statutes:** References to laws in this by-law are meant to refer to the statutes, as amended from time to time, that are applicable within the Province of Ontario.
- 1.04 **Severability:** If a court or tribunal of competent jurisdiction declares any portion of this by-law to be illegal or unenforceable, that portion of this by-law shall be considered to be severed from the balance of the by-law, which shall continue to operate in full force and effect.

## **Section 2.00: Designation**

- 2.01 45 Victoria Avenue North, Lindsay, City of Kawartha Lakes, is designated as being of historic interest and value, described further in Schedule "A". This designation shall not preclude any changes that may be deemed necessary for the efficient use of the building but that any and all such changes shall be in keeping with the original and present character of the building and in consultation with the municipal heritage committee.
- 2.02 The City is hereby authorized to cause a copy of this by-law to be registered against the property described above in the proper Land Registry Office.
- 2.03 The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Trust, and to cause notice of the passing of this by-law to be published in the newspaper.

## **Section 3.00: Enforcement, Offence and Penalties**

- 3.01 **Enforcement:** This by-law may be enforced by every municipal law enforcement officer and police officer.
- 3.02 **Offence and Penalty:** It is an offence for a person to contravene any provision of this by-law, and every person who contravenes this by-law is guilty of an offence and, on conviction, is liable to a fine in accordance with the provisions of the *Provincial Offences Act* and to any other applicable penalty.

## **Section 4.00: Administration and Effective Date**

- 4.01 **Administration of the By-law:** The Director of Development Services is responsible for the administration of this by-law.
- 4.02 **Effective Date:** This By-law shall come into force on the date it is finally passed.

## **Section 5.00      Repeals**

5.01    Repeal: Town of Lindsay By-law 1988-85 is repealed.

By-law read a first, second and third time, and finally passed, this 25 day of September, 2018.

## **Schedule 'A' to By-law 2018-171**

Being a By-law to designate 45 Victoria Avenue North, Lindsay, City of Kawartha Lakes, as being of cultural heritage value and interest.

### **Description of Property:**

Located on the west side of Victoria Street North, this three storey yellow brick home is situated between Front Street and Bond Street West.

### **Legal Description:**

TOWN PLAN PT LOT 14 PT LOT;15 N BOND ST W

### **Reason for Designation:**

#### **Architectural Design or Physical Value:**

The three storey, yellow brick house is believed to have been built in 1880 by Thomas Bradburn. The home features the Mansard or Second Empire style and is of architectural significance which merits designation. The most prominent feature of the home is its style of roof which has dormers persisting around the home decorated with of bargeboards. The main entrance of the home is the entrance facing Bond Street. This entrance features a beautifully decorated verandah that has a successive stream of bargeboard.

#### **Attributes to be Conserved:**

- Yellow brick
- Second empire style Mansard roof line
- Three dormers with gable bays on the front facing third storey and three dormers on the south facing third storey
- Verandah with significant Gothic brackets and bargeboard
- Decorative Rococo brick and wooden brackets under soffits between second and third storey
- Wedge arched brickwork above windows
- Upper roofline cornices
- 2 brick chimneys
- Original windows
- The large bay sectional window on the west side of property featured on the first storey
