THE CORPORATION OF THE TOWNSHIP OF NORTH HIMSWORTH

BY-LAW NO. 2001-791

Being a by-law to designate property known municipally as the Callander Bay Heritage Museum, 107 Lansdowne East, Callander, Ontario as being of historic value or interest.

WHEREAS Section 29 of the Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

AND WHEREAS the Council of the Corporation of the Township of North Himsworth has caused by resolution its intention to designate the Callander Bay Heritage Museum located at 107 Lansdowne Street East, Callander, Ontario a Heritage Building and served Notice upon the Ontario Heritage Foundation and has used such Notice of Intention to be published once in a local newspaper having general circulation in the municipality;

AND WHEREAS no objection to the proposed designation has been served on the Clerk of the Municipality;

NOW THEREFORE the Council of the Corporation of the Township of North Himsworth enacts as follows:-

- 1. That there is designated as being of historical and architectural value that part of the real property, the former home and office of Dr. Allan Roy Dafoe, world famous country doctor to the Dionne Quintuplets, known as 107 Lansdowne Street East, Callander, Ontario. The specific features of the designation including all building elevations and the following exterior and interior features of the original building: (1) Exterior: Stone foundation, brick walls, window openings, wooden windows, glazing, wooden sills and brick chimneys. The front door, porch and rear basement entrance; the chain-link fence that includes an angled barbed wire on top of fence; (2) Interior: All door, window and floor mouldings; the tongue and groove wooden floors, walls and ceilings in the dining and living room. The fireplace, and bookshelves in the living room. The original dispensary on the main floor; hand rails on stairs leading to second floor as well as the banister on the second floor; (3) Landscape: The lilac hedge on the west side of the property; tree on the Northwest corner, picket fence on the North and West sides; the front gate and the flower beds around the house.
- 2. That the distinguishing name for the house shall be The Dr. Allan Roy Dafoe House.
