



NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Cambridge intends to designate the exterior of the following property of architectural significance under Part IV of the Ontario Heritage Act, R.S.O. 1990, Chapter 337.

> The Rose Window on the main elevation of the property municipally known as 51 Ainslie Street North, Wesley United Church.

The rose window on the Wesley United Church is recommended for designation for architectural reasons. The building itself was constructed in 1878 of granite and limestone. The subject window was installed in 1903 to replace the original. The design is a geometric pattern. It represents a method of construction now rarely used and makes an important contribution to the physical appearance of this building.

ANY PERSON MAY, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the City of Cambridge, notice of his objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a notice is received the Council of the Corporation of the City of Cambridge shall refer the matter to the Conservation Review Board for a hearing.
