Being a by-law of the City of Cambridge to designate the Rose Window on the main elevation on the exterior of property referred to as Wesley United Church on the property municipally known as 49 Ainslie Street North, Cambridge, Ontario, as a property of architectural and historical significance.

WHEREAS the Ontario Heritage Act, R.S.O., 1990, c. 337 authorizes the Council of a municipality to enact by-laws to designate real property including all buildings and structures thereon, to be of architectural value or interest;


AND WHEREAS Notice of Intention to so designate the Rose Window on Wesley United Church, Cambridge, Ontario, have been duly published and served;

NOW THEREFORE, THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF CAMBRIDGE ENACTS AS FOLLOWS: -


1. THAT there is designated as being of architectural significance the Rose Window on the exterior of the original structure located on the real property, more particularly described in Schedule "A" attached hereto, known as Wesley United Church, Cambridge, Ontario. The reasons for designation are as set out in Schedule "B" attached hereto.
2. THAT the City of Cambridge is hereby authorized to cause a copy of this by-law to be served upon the owner of the said property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Cambridge.

SCHEDULE "A"

TO BY-LAW NO. 56-94

OF THE

CORPORATION OF THE CITY OF CAMBRIDGE

All and singular that certain parcel or tract of land and premises, situate, lying and being in the City of Cambridge, in the Regional Municipality of Waterloo and Province of Ontario and being described as Lots 2 and 3 of Plan 615.

SCHEDULE "B"

TO BY-LAW NO. 56-94

OF THE

CORPORATION OF THE CITY OF CAMBRIDGE

The Rose Window on the main elevation of the Wesley United Church, located at 49 Ainslie Street North, is designated for architectural reasons. The window is an important component on this significant building. This circular window is beautifully designed and approximately 14 feet in diameter.

In accordance to the Heritage Conservation Policy in the Official Plan, the Rose Window constitutes a heritage resource for the following reasons:

- i) it is a well preserved, representative example of a method of construction now rarely used;
- ii) it is a good, well preserved and representative example of its style of stained glass;
- iii) it makes a significant contribution to the entire building which is important to the streetscape;
- iv) it is generally recognized as an important City landmark.
