CORPORATION OF THE CITY OF CAMBRIDGE

Being a by-law of the Corporation of the City of Cambridge to amend By-law No. 93-98, being a by-law to designate the exterior of the structure located at 300 Maple Grove Road, Cambridge, Ontario, as a property of architectural and historic significance.

WHEREAS the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18 authorizes the Council of a municipality to enact by-laws to designate real property including all buildings and structures thereon, to be of historic and architectural value or interest;

AND WHEREAS Notice of Intention to Designate 300 Maple Grove Road, Cambridge, Ontario, have been duly published and served;

AND WHEREAS the legal description contained in By-law No. 93-98 is incorrect;

NOW THEREFORE, THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF CAMBRIDGE ENACTS AS FOLLOWS: -

1. THAT Schedule "A" to By-law No. 93-98 be deleted and that Schedule "A" attached to and forming part of this by-law be substituted therefor.

BY-LAW NO. 206-98

of the

CORPORATION OF THE CITY OF CAMBRIDGE

ALL AND SINGULAR that certain parcel or tract of land and premises, situate, lying and being in the City of Cambridge, in the Regional Municipality of Waterloo, (formerly in the Township of Waterloo) and being composed of Part of Lots 19 and 20 on Beasley's Broken Front Concession in said township, containing by admeasurement of 101.760 acres and more particularly described as Parts 3, 4, 5, 13 and 21, on Reference Plan 58R-10806, and subject to any easement in favour of Hydro Electric Power Commission of Ontario shown as Part 3 on Plan WDR-49.
