#### NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Cambridge intends to designate the exterior of the following property for its cultural heritage value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1990, Ch.0.18 as amended 2005.

## 126 King Street West

#### Statement of Cultural Heritage Value or Interest

The subject property is the red brick residence associated with the Dover Flour Mills complex now known as P & H Milling on King Street West in the area of Cambridge often referred to as Cambridge Mills.

Dover Flour Mills is one of the oldest operating mills in the Region of Waterloo and this residence is believed to have been built for John Cherry, one of the mill owners, in 1879. The residence stayed in the Cherry family until 1976 when it was sold to Dover Industries Limited

# **Description of Heritage Attributes**

The predominate feature of this red brick residence is the porch which wraps around three sides of the residence and is supported by massive columns set on sandstone piers. Sandstone appears again in the cut stone foundation of the principal building. The columns on the King Street façade are smooth, fluted and with Corinthian details at the top. The massive chimneys are intricately detailed. There are brackets and dentils at the soffit and fascia level. Dormers punctuated the roof.

The citing of this residence in such close proximity to the industry complex is indicative of an era when business owners wanted to be near their businesses. The property is recommended for designation because of its association with the people who established the flour mill industry and because of its architectural significance.

ANY PERSON MAY, within thirty days of the publication of this notice, send by registered mail or deliver to the Clerk of the City of Cambridge, notice of their objection and all relevant facts. If such a notice is received the Council of the Corporation of the City of Cambridge shall refer the matter to the Conservation Review Board for a hearing.
