Re: Notice of passage of by-laws to adopt the Heritage Conservation District Plan for the Centretown and Minto Park Heritage Conservation Districts under Part V, Section 41.1 (2) of the *Ontario Heritage Act*

Dear Sir or Madam,

City Council, at its meeting held on Wednesday August 31, 2022, passed By-law 2022-278 and By-law 2022-279, with reference to the above-noted matter:

2022-278 A by-law of the City of Ottawa to adopt the Heritage Conservation District Plan for the Centretown Heritage Conservation District; and

2022-279 A by-law of the City of Ottawa to adopt the Heritage Conservation District Plan for the Minto Park Heritage Conservation District.

Notice of passage of by-laws will be published in the Ottawa Citizen and Le Droit, both newspapers having general circulation in the City of Ottawa, on 17 September 2022.

Section 41 (4) of the *Ontario Heritage Act* establishes that any person wishing to object to the passing of these by-laws may appeal to the Ontario Land Tribunal by submitting a letter of objection outlining the reasons for the objection and any other relevant information. The letter and filing fee charged by the Ontario Land Tribunal (see below) must be received by the Clerk of the City of Ottawa within 30 days after the newspaper publication.

The letter can be sent by registered mail to the City Clerk at 110 Laurier Avenue West, Ottawa, Ontario, K1P 1J1, or can be delivered in person, by appointment, at the following coordinates:

Should a notice of appeal be received, the Council of the City of Ottawa will refer the matter to the Ontario Land Tribunal for a hearing. A filing fee must accompany the appeal letter. For


