Attached for your records is a copy of Town of Fort Frances By-Law 17/00 enacted February 28, 2000 to designate the real property known as Fort Frances Museum and Cultural Centre at 259 Scott Street, Fort Frances under Part IV of the *Ontario Heritage Act*.

Notice of passing of the by-law has been published in the Fort Frances Times. A copy of the by-law and the notice has been presented to the Town of Fort Frances as owner of the property. The reasons for designation were set out in the notice and are as follows:

- the building was erected at the end of the 19th century and continues to serve the community today in the 21st century; it currently houses the Fort Frances Museum and Cultural Centre
- as a building in excess of 100 years of age, it has played a prominent role in the community and has served a variety of needs as the community has developed in the previous two centuries and now in the current century
- it has historically been a focal point for community activities
- it has a rich historical and cultural value to the Town of Fort Frances and its residents which continues into the present
- the location of the building also serves to provide character to the heart of the community

TOWN OF FORT FRANCES

BY-LAW NO.17/00

(Being a by-law to designate the property known municipally as 259 Scott Street (Fort Frances Museum and Cultural Centre) as being of historic value or interest);

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1990, c.O.18, authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

AND WHEREAS the Council of the Corporation of the Town of Fort Frances has caused to be served on the owners of the lands and premises known as Fort Frances Museum and Cultural Centre at 259 Scott Street, Fort Frances, Ontario and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having general circulation in the municipality;

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality;

NOW THEREFORE Council for the Corporation of the Town of Fort Frances HEREBY ENACTS as follows:

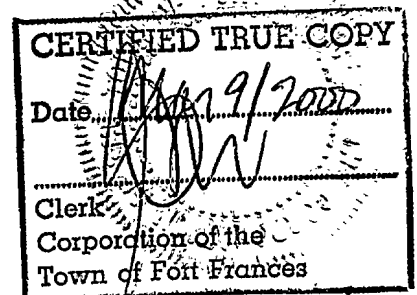
1. There is designated as being of historical value or interest the real property known as Fort Frances Museum and Cultural Centre at 259 Scott Street, Fort Frances, Ontario, more particularly described in Schedule "A" hereto.
2. The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in a newspaper having general circulation in the municipality.

This by-law shall come into force and take effect on the final passing thereof.
