## BY-LAW NO. 2012-09

BEING a By-Law to De-Designate St. Andrews Presbyterian Church.

WHEREAS the Council of the Corporation of the Township of Huntingdon now the Corporation of the Municipality of Centre Hastings passed By-law Number 2104-83 on February 12, 1983 that designated property known municipally as St. Andrews Presbyterian Church situated on part of Lo 3, Concession 5 as being of architectural and historical value.

AND WHEREAS the current owners of St. Andrews Presbyterian Church have asked Council to de-designate the property.

## NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALIT CENTRE HASTINGS ENACTS AS FOLLOWS:

THAT By-law Number 2104-83 passed on February 12, 1983 is hereby repealed.
