THE CORPORATION OF THE TOWN OF GRIMSBY

BY-LAW NO. 05-69

A BY-LAW TO DESIGNATE THE STRUCTURES KNOWN AS THE QUEEN'S LAWN CEMETERY GATES AT 109 MAIN STREET EAST AS BEING OF CULTURAL HERITAGE VALUE OR INTEREST

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18, authorizes the Council of a municipality to enact by-laws to designate real property, including buildings and structures thereon, to be of architectural or historical value or interest; and

WHEREAS the Council of the Corporation of The Town of Grimsby has caused to be served on the Ontario Heritage Trust, notice of intention to so designate the aforesaid structures and has caused such notice of intention to be published in a newspaper having general circulation in the municipality; and

WHEREAS no Notice of Objection to the proposed designation has been served on the Town Clerk of the municipality; and

WHEREAS the reasons for designation are set out in Schedule 'B' hereto.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF **GRIMSBY ENACTS AS FOLLOWS:**

- 1. There is designated as being of cultural heritage value or interest the real property more particularly described in Schedule 'A' attached hereto and only including the structures known municipally as the Queen's Lawn Cemetery Gates at 109 Main Street East.
- The Town Clerk is hereby authorized to cause a copy of this by-law to be 2. registered against the property described in Schedule 'A' attached hereto in the proper land registry office.
- 3. The Town Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforementioned property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in a newspaper having general circulation in the municipality.

READ A FIRST TIME this 19th day of September, 2005.

READ A SECOND AND THIRD TIME AND FINALLY PASSED this 19th day of September, 2005.

SCHEDULE "B"

109 MAIN STREET EAST (QUEEN'S LAWN CEMETERY GATES)

The reason for the proposed designation is to recognize the gates at the entrance of the Queen's Lawn Cemetery, the first Town cemetery.

The entrance gates to Queen's Lawn Cemetery were erected in 1921 as a memorial to the citizens of Grimsby and North Grimsby who gave their lives during World War I. The gates were erected with funds provided by the women of the district who saved and collected donations.
